**OTS Membership Terms and Conditions**

1. OTS is a private business which is wholly owned by Mags Unlimited LLC. Acceptance for membership in OTS does not confer on the holder any membership, rights, or ownership interest in Mags Unlimited LLC. OTS facilities are available for use by all OTS Members, guests of Members, private citizen groups and by the general public. OTS' Memberships are available to provide preferred access, discounts for merchandise, services and facility use, and other benefits to OTS Members. OTS Membership is subject to the Membership

Terms and Conditions stated herein. Membership will be granted, and may be revoked, at the sole discretion of OTS.

2. As part of the consideration for Membership, the Member hereby agrees to remain a Member and pay the Membership Dues for a period of not less than one (1) year from the date of this Agreement. OTS is entitled to recover its costs, including reasonable attorneys' fees, incurred in collecting sums due to OTS under this or any other Membership provision or otherwise. A cancellation fee of \$100 dollars or the balance of the contract, whichever is less, will be assessed to the member if cancellation is required within the first twelve (12) months of this agreement.

3. All Memberships (except Charter Lifetime Members ("CLM")) are subject to payment of a one-time non-refundable Initiation Fee and timely monthly payment of Membership dues. The Initiation Fee and Membership dues for each level of Membership vary based on the level of Membership purchased, special OTS promotions and Membership availability. Membership dues and benefits may be reviewed and adjusted by OTS at any time without notice.

4. Members may select one of the following methods to make their monthly payment of Membership dues: Automatic monthly credit/debit payment from a VISA, MasterCard, American Express, or Discover Cards. A \$20 fee will be assessed for any automatic debit that is rejected for insufficient funds or any failed credit charge.

5. All Members, guests, and other OTS facility users must follow all OTS Safety Standards and Range Rules, and must read, and agree to the terms of the OTS Release, Waiver of Liability, Assumption of Risk and Indemnity Agreement which is incorporated by reference into the OTS Terms and Conditions of Membership. All first-time Members, guests, and other OTS facility users must participate in the OTS range orientation.

6. All explained more fully in the OTS Release, Waiver of Liability, Assumption of Risk and Indemnity Agreement, guests must be accompanied by a Member to be admitted to the firing line. Members are responsible for all actions taken by their guests and will hold OTS / Mags Unlimited LLC harmless for property damage, accidents and injuries to or caused by guests.

7. All Members and guests are subject to the general policies and rules of operation and administration of OTS, all of which are intended to provide a safe, professional, friendly and family-oriented club.

## RANGE RULES

- **ALWAYS** treat firearms as if they are loaded. **ALWAYS.**
- **ALWAYS** keep the muzzle (end of the barrel where the bullet exits) pointed downrange (toward the target).
- **ALWAYS** keep your finger off of the trigger and outside of the trigger guard until you are pointed at your target and ready to shoot.
- **ONLY** shoot at **YOUR** designated paper/cardboard target. Anyone observed targeting anything in the range except their **specifically designated and allowable target** will be immediately and permanently removed from the range. Whether intentionally inflicted or not, you may be held financially liable for any damage caused by you (or a member of your group) to our target carrier equipment, range/store equipment & fixtures, shooting stalls and light fixtures.
- **ABSOLUTELY NO FIREARM HANDLING OR CLEANING IN THE PARKING LOT OR PATIO AREAS.** All firearms brought onto OTS premises **MUST** be secured in a case, bag or holster until safely inside the shooting range.
- Use the appropriate size target – placed at eye level – to ensure that your shots strike the backstop and not the floor, ceiling or target holder.
- No more than 2 people per lane.
- Please do not remove or replace the cardboard target backers – ask an OTS Range Officer for assistance if one needs to be replaced.
- All first-time Members, guests and other OTS facility users must participate in the OTS Orientation.
- Never bring a loaded weapon into or out of the range. If your gun malfunctions and you are unable to safely correct the problem, place it on the shelf in your booth facing downrange and notify OTS personnel immediately.
- No firearm handling allowed outside of the shooting booth.
- Commands issued by OTS personnel must be obeyed immediately and without question.
- All firearms not on the firing line must be unloaded with their action open.
- Eye and ear protection are required at all times on the range.
- ***The use of tracer, armor piercing, incendiary, frangible and steel core or steel cased or aluminum cased ammunition is strictly prohibited. Failure to observe this policy will result in a loss of range privileges. OTS reserves the right to inspect all ammunition used at our facility.***
- Magazines should be unloaded prior to range check-in.
- Reloads will be permitted provided they are: a) lead-cored b) brass-cased c) loaded according to commercial manufacturers guidelines for proper propellant charges and use clean burning powders.
- No muzzle-loading/black powder firearms allowed.
- Shotguns are allowed with slugs only. No pistol grip shotguns.
- No one other than OTS personnel may go forward of the firing line.
- Shooters must know and understand all of the operating and safety features of the firearms they are using prior to shooting in the range.
- Alcohol or drug use before or while shooting is strictly prohibited. Any person suspected of drug or alcohol use will not be allowed to use the range and may be asked to leave the premises.
- If a 'Cease Fire' command is given, stop shooting **IMMEDIATELY** and wait for further instructions from OTS personnel.
- OTS reserves the right to inspect all firearms and ammunition for safety and policy considerations.
- No drawing from the holster, unless it is a component of an officially sanctioned and supervised range event or training exercise.

- Double tap or rapid fire shooting practice is allowed, but must be done safely and responsibly. The shooter's ability will be observed and continued practice will be at the sole discretion of OTS.
- Cell phone usage, including texting, is prohibited while handling firearms.
- If you wish to engage in tactical, 3-gun type shooting, please consult with OTS personnel before doing so.
- Children under the age of 12 are generally prohibited on the range. Please see OTS management if you would like to bring someone under the age of 12. Persons under the age of 18 must be accompanied by their parent or guardian and supervised at all times.
- Report any unsafe activity or conditions to OTS personnel immediately.
- No flash photography is permitted on the range.
- Food & beverages (except bottled water), chewing gum, smoking and smokeless tobacco are prohibited on the range.
- Pregnant women are not allowed on the range.
- Shooters may collect ONLY their own brass and ONLY behind the firing line. Be aware that we clean the range area regularly, so if you wish to collect your brass, please do so promptly.
- Always wash your hands immediately after shooting.

This Release, Waiver of Liability, Assumption of Risk and Indemnity Agreement is given on the date signed below by the **Customer** in favor of the Mags Unlimited LLC D.B.A. **On Target Sports (OTS)** and its **Owners** (including OTS's officers, heirs and successors), employees and agents. **PLEASE INITIAL EACH LINE ITEM.**

I am the **Customer** and I am being given permission to use the Shooting Range and related facilities. In consideration of being allowed to be a **Customer** at the **OTS** Shooting Range, on behalf of myself, my personal representatives, heirs, executors, next of kin, spouses, minor children and assigns, I agree as follows:

I understand that I am entering a private shooting range at my own risk where I will encounter high levels of noise and the discharge of ammunition from **Firearms** (including hand guns, rifles and machine guns). I am entering this property at my own risk and acknowledge the risks and dangers that exist in my use of any and all firearms and my participation in **Shooting Activities** (including all activities involving **Customer** in any manner and of any nature whatsoever that occur with respect to the Shooting Range including, but not limited to target practice, tactical maneuvers, training and instruction in the use and handling of **Firearms**). **Shooting Activities** further include all activities in which I am engaged from the time I arrive at **OTS** until the time I leave, regardless of the time or location of those activities.

I acknowledge and understand that **Shooting Activities** are inherently hazardous and involve both known and unanticipated risks which could result in damage or destruction of property and physical or emotional injury, including paralysis or death of myself or of other persons, and I assume the risks that could result in physical and/or emotional injury, paralysis, death, or damage to myself, to property, or to third-parties. Inherent risks include, but are not limited to: flying or ricocheting bullets or debris, noise; being shot by or shooting myself or others; partial or total loss of eyesight or hearing; inhalation or other harmful contact with lead or other contaminants; being struck by flying or falling objects; negligent conduct or intentional misconduct of other customers and participants. I understand that such risks cannot be eliminated without compromising the essential qualities of **Shooting Activities**.

I acknowledge and understand that, in the event any such property damage or physical or emotional injury occurs, **OTS** has no duty to undertake first-aid or rescue operations or procedures.

I acknowledge and understand that **OTS** makes no warranty as to the design, manufacture, maintenance, condition or fitness for any particular purpose of any range facilities or equipment, including, but not limited to: firearms, ammunition, eye/hearing protection, and first-aid supplies.

I agree to release and hold harmless Mags Unlimited LLC / **OTS**, its **Owners**, employees and agents, to the maximum extent allowed by law, against any and all claims, demands, damages, expenses, causes of action, attachments of property, liability, injury, death or financial compensation which I may incur directly or indirectly as a result of my participation in **Shooting Activities**, whether caused by negligent conduct or intentional misconduct of myself or others, including Mags Unlimited LLC / **OTS**, its Owners, employees, agents and customers.

## CENTERFIRE RIFLE SHOOTER RULES ADDENDUM

**DUE TO THEIR POWER, CENTERFIRE RIFLES CAN SEVERELY DAMAGE AND/OR DESTROY OTS RANGE EQUIPMENT.**

- AS A CENTERFIRE SHOOTER, I AGREE TO SHOOT ONLY BRASS-CASED, LEAD-CORED AMMUNITION MEETING THE SPECIFICATIONS FOR MY FIREARM(S), AT MY SPECIFICALLY DESIGNATED AND ALLOWED TARGET.
- I CERTIFY THAT I WILL NOT SHOOT ANY STEEL- CASED OR STEEL-CORED AMMUNITION AT OTS AND DO NOT HAVE ANY SUCH AMMO *IN MY POSSESSION*.
- I UNDERSTAND THAT IF I AM FOUND SHOOTING STEEL-CORED AMMUNITION AT OTS, I WILL BE **PERMANENTLY BARRED** FROM THE OTS RANGE AND **HELD FULLY FINANCIALLY LIABLE** FOR ANY DAMAGES I INFLICT ON OTS EQUIPMENT.
